Information on the processing of personal data ex art. 13-14 EU Reg. 2016/679

Migliora S.R.L. as the owner of the processing of your personal data, pursuant to EU Regulation 2016/679 hereinafter 'GDPR', hereby informs you that the above legislation provides for the protection of data subjects regarding the processing of personal data and that this treatment will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Your personal data will be processed in accordance with the legal provisions of the above-mentioned legislation and the confidentiality obligations therein.

Purposes and legal basis of the processing: in particular, your data will be used for the following purposes relating to the execution of measures connected with contractual or pre-contractual obligations:

Processing methods. Your personal data may be processed in the following ways:

- collection of data via computer or telematics;

Reg.to UE 2016/679: Artt. 15, 16, 17, 18, 19, 20, 21, 22 - Rights of the data subject

1. The data subject shall have the right to obtain confirmation as to whether or not personal data concerning him exist, regardless of their being already recorded, communication of such data in intelligible form and the possibility to lodge a complaint with the Supervisory Authority.
2. The interested party has the right to obtain the indication:

the origin of the personal data
 the purposes and methods of processing
 the logic applied in the event of processing carried out with the aid of electronic instruments;
 the identity of the data controller, data processors and the representative designated pursuant to article 5, paragraph 2;
 the entities or categories of entity to whom or which the personal data may be communicated and who or which may get to know said data in their capacity

1. The interested party has the right to obtain:

updating, rectification or, where interested therein, integration of the data;
 the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which they were collected, certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or which the data were communicated;
 the portability of the data.

The data subject shall have the right to object, in whole or in part:

for legitimate reasons to the processing of personal data concerning him/her, even if pertinent to the purpose of collection;
 to the processing of personal data concerning him/her, where it is carried out for the purpose of sending advertising materials or direct selling or else
