EU Reg. 2016/679: Articles 15, 16, 17, 18, 19, 20, 21, 22 - Rights of the data subject

1. The data subject shall have the right to obtain confirmation as to whether or not personal data concerning him exist, regardless of their being already recorded, communication of such data in intelligible form and the possibility of lodging a complaint with the supervisory authority.

2. The interested party has the right to obtain information on:

the origin of the personal data

the purposes and methods of processing

the logic applied in the event of processing carried out with the aid of electronic instruments;

the identity of the data controller, data processors and the representative designated pursuant to article 5, paragraph 2;

the entities or categories of entity to whom or which the personal data may be communicated and who or which may get to know said data in their capacity

3. The interested party is entitled to obtain:

the updating, rectification or, where interested therein, integration of the data
the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for
certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or
the portability of the data.

4. The interested party has the right to object, in whole or in part, to:

for legitimate reasons to the processing of personal data concerning him/her, even if pertinent to the purpose of collection;
to the processing of personal data concerning him/her, where it is carried out for the purpose of sending advertising materials or direct selling or else
